Miracle Approved! Father McGivney to be Beatified!

The Vatican announced that Father McGivney can be declared "Blessed," the step just prior to sainthood

ROME – The Vatican today (May 27) announced that Pope Francis approved the promulgation of a decree recognizing a miracle attributed to the intercession of the founder of the Knights of Columbus, Venerable Father Michael J. McGivney, a Connecticut priest who served his flock during the pandemic of 1890, before himself becoming ill and dying of pneumonia.

The pope's action means that Father McGivney can be declared "Blessed," the step just prior to sainthood. An additional miracle attributed to Father McGivney's intercession will be required for his canonization as a saint.



Our Lord's Presence in these Difficult Days

What comes to mind when we hear the words plague or pestilence? Such terms not only imply a disease with deadly consequences but a disease that is mysterious, unknown and without human control. What about the word pandemic? It sounds worse in every way. The term describes not a disease itself but how extensive and prevalent the appearance of the disease is geographically. Governments like ours in Canada is responding to the guidance of health care specialists by giving us practical guidelines to protect people from contracting Covid-19 and from passing it on to others. Unfortunately there is no effective antidote and all we can do is take measures to enhance our ability to avoid it or reduce the likeliness of passing it on to others.



The pandemic has brought forth so many challenges to us on so many levels. It is easy to become hysterical and fearful in the midst of so much uncertainty. It is precisely at a time like this that we need to renew our relationship to God and to share with him our anxieties and our need for his intervention. There is so much we have no control over at a time like this. Many of us are used to being in control but the pandemic that has befallen us has thrown that control out of whack. What do we do? We need to pray. We need to deepen our relationship with our Lord Jesus Christ and his Church. It is vital to tell our Lord our fears, implore both his intervention to take our anxieties and fears away and ask for the grace to accept His will and see this crisis through the eyes of faith. Pro-Life Coordinator Report

Brothers and Sisters in Christ;

What has the Coved-19 pandemic and the present lock-down of social and economic life meant for those of us committed to the protection of innocent human life from conception to natural death. Much of our own pro-life work as Knights, including our parish lapel rose campaign is on hold, as is the work of our friends in the local Right to Life Association. The Association is seeking new ways to advance the pro-life message through social media and in other ways. Though working from home, the Right to Life staff continue to take calls from women facing crisis pregnancies and considering abortion.



Meanwhile, the federal government introduced Bill C-7 with changes in our 2016 Euthanasia and assisted suicide that would undermine many of the safeguards in that law and greatly increase the number of Canadians likely to die at the hands of doctors moves forward.

We learn from our military who have come to the help of elderly residents of senior care facilities of the very poor care so many of our fellow citizens have received there.

I would urge brother Knights to check out the very good on-line work of fellow Knight Alex Schadenberg, Director of the Euthanasia Prevention Coalition, on the faults of Bill C-7 and on the horrors recently discovered in our senior care homes.

Pro-Life Coordinator Report

On February 24, the federal government introduced Bill C-7 in response to the Quebec Superior Court decision that struck down the requirement in the law that a person's "natural death must be reasonably foreseeable" before qualifying for death by lethal injection.

What does Bill C-7 do?

- **1.** Bill C-7 removes the requirement in the law that a person's natural death must be reasonably fore-seeable in order to qualify for assisted death. Therefore, people who are not terminally ill can die by euthanasia. The Quebec court decision only required this amendment to the law, but Bill C-7 went further.
- **2.** Bill C-7 permits a doctor or nurse practitioner to lethally inject a person who is incapable of consenting, if that person was previously approved for assisted death. This contravenes the Supreme Court of Canada Carter decision which stated that only competent people could die by euthanasia.
- **3.** Bill C-7 waives the ten-day waiting period when a person is deemed to be "terminally ill." Thus a person could request death by euthanasia on a "bad day" and die the same day. Studies prove that the "will to live" fluctuates.
- **4.** Bill C-7 creates a two track law. A person who is deemed to be terminally ill would have no waiting period while a person who is not terminally ill will have a 90 day waiting period before being killed by lethal injection.
- **5.** Bill C-7 falsely claims to prevent euthanasia for people with mental illness. The euthanasia law permits MAiD for people who are physically or psychologically suffering that is intolerable to the person and that cannot be relieved in a way that the person considers acceptable." However, mental illness, which is not defined in the law, is considered a form of psychological suffering.

Why should I be concerned?

Euthanasia (MAiD) was legalized in June 2016. From that date until December 31, 2019, there have been more than 13,500 MAiD deaths in Canada, with more than 5400 in 2019 alone.

Bill C-7 expands the law to permit anyone who considers their physical or psychological suffering to be intolerable to qualify for death by lethal injection, even if effective medical treatments for their condition exists. Bill C-7 allows medical homicide for people who need treatment and care. (Link to Bill C-7)


